**Amendment no.2 to Dean´s decision A-14/8/RD on
Granting allowances, gifts, and returnable loans from
Social fund of the Faculty of Science, Palacký
University Olomouc**

I. Subject matter of the amendment

This document alternates the wording of Dean´s Decision of the following items:

1. Article 1 „Types of allowances and regulations for their granting”

- a) In Section 1 „The contribution to supplementary pension with state contribution" the term "supplementary pension with state contribution" has been replaced by the term "supplementary pension with state contribution and contribution to supplementary pension savings”.
- b) There has been item no.5 added to Article 1 stipulating the following:

In academic year 2017/2018, i.e. starting on 1. 9. 2017 and ending on 31. 8. 2018, resp. starting with the payment date for period 9/2017 and ending with the payment date for period 8/2018, the Faculty will contribute the amount of CZK 10 per 1 meal voucher or 1 meal in the UP cafeteria to the boarding of its employees from the social fund. This allowance is granted to employees who are entitled to meals allowance pursuant to Article 3 (5) of Rector's Directive on Rules of Creation and Use of the Social Fund at the Palacký University Olomouc.

2. Article 3 “Procedure of granting allowances”

- a) In Section 1 „The contribution to supplementary pension with state contribution" the term "supplementary pension with state contribution" has been replaced by the term "supplementary pension with state contribution and contribution to supplementary pension savings”.

II. Final provisions

- 1. Other provisions of Dean´s decision on Granting allowances, gifts, and returnable loans from Social fund of the Faculty of Science, Palacký University Olomouc are not subject to change.
- 2. This decision was based on the affirmative recommendation of Dean´s Collegium negotiated and approved by the Committee of the Basic organization of higher education´s trade union at PrF UP on 8. 8. 2017.
- 3. This document enters into force and effect on 1. 9. 2017.
